





# Overview: EPA Thriving Communities Grantmaking Program

**Purpose**: To reduce barriers and make it easier for small, community-based organizations to access federal environmental justice funds.

**Funding**: \$600 million from Inflation Reduction Act (IRA).

**Who and what**: Nationally 10 grantmakers covering all EPA regions will distribute thousands of grants over 3 years.



### What is Environmental Justice?

**Environmental justice** is the **fair treatment** and **meaningful involvement** of all people with respect to the development, implementation, and enforcement of environmental laws policies. Fair treatment means that no one group of people should bear a disproportionate share of the negative environmental consequences resulting from industrial, municipal, and commercial operations; the execution of federal, state, local, and tribal environmental programs and policies; or changing environmental conditions.

### **COMMUNITY OF FOCUS**

No one group of people should bear a disproportionate share of negative environmental consequences

Who is being disproportionately affected? What specific communities or populations need to have a specific focus?



### **Overview: MAP EJ Grants Hub**

Purpose: Provide \$48 million in grants over 3 years to communities across EPA Region 8 (CO, MT, ND, SD, UT, WY, 28 Tribes) working on environmental justice efforts.

### Goals:

- Get money and resources to the environmental justice communities
- 2. Reduce the burden of getting and managing a federal grant
- 3. Strengthen the capacity of local organizations to support long-term sustainability

### **Grant Overview**





### Tier 1 Grants: Assessment

Intended to explore and/or measure an EJ issue to better understand its impact on a community of focus, and/or to inform a future invention.

Can inform the **initial stage** of a project through **assessing** environmental and public health concerns.

Applicants are **not expected to propose an intervention or solution to the issue.** 

**Budget**: Up to \$150,000

Project Period: 1 year

- Sampling
- Testing
- Monitoring

- Surveys and studies

## Tier 2 Grants: Planning

**Budget**: Up to \$250,000

**Project Period**: 1-2 years

Intended to engage, educate, or coordinate partners and community members to prepare to address an EJ issue in a community of focus.

Involves working with a community to **lay the groundwork for an intervention** and/or to **involve and mobilize the community.** 

**Planning phase** of a project, for applicants who already have a strong understanding of their local issues and are ready to formulate a plan to address those issues.

- Planning
- Partnership-building
- Public outreach and education (as part of the planning process for future work)
- Coordination with community stakeholders to address environmental issues
- Training activities for community organizations and community members to build capacity for future action
- Projects and activities to spur community involvement
- Smaller land purchases and acquisitions that require less than half of the total amount of subgrant funding

## Tier 3 Grants: Development

Implementing or moving toward an implementation of an intervention for an identified EJ issue with a community of focus

Describes clearly defined implementation steps for an intervention

Implementation phase of a project, for applicants who already have a strong understanding of their local environmental and/or public health issues, have already formulated a community-wide plan addressing those issues, and/or are now ready to develop the **technical aspects** of the project (i.e., implement the project on the ground).

**Budget**: Up to \$350,000

**Project Period**: up to 2 years

- Implementation of project plans
- Public outreach and education
- Blueprints for construction or cleanup projects, schematics, and technical development
- Work to get permits in place directly related to an environmental project
- Smaller land purchases and acquisitions that require less than half of the total amount of subgrant funding

# Non-competitive Tier 1: Assessment

Eligible: Wyoming, Utah, South Dakota, North Dakota, and Tribes

Non-competitive awards are designed for **severely capacity-constrained organizations**. Applicants will go through a non-competitive process where they will need to include an **organizational capacity assessment** and **provide a project description**.

Intended to explore and/or measure an EJ issue to better understand its impact on a community of focus, and/or to inform a future invention.

Can inform the **initial stage** of a project through **assessing** environmental and public health concerns.

Applicants are **not expected to propose an intervention or solution to the issue.** 

**Budget**: Up to \$75,000

Project Period: 1 year



# Additional things to know

We anticipate three cycles of grant applications

Applicants can apply to multiple cycles

A single applicant can receive up to 2 awards for a total of up to \$600,000

# **Possible Project Topics**

- Air quality & asthma
- Fence line air quality monitoring
- Monitoring of effluent discharges from industrial facilities
- Water quality & sampling
- Small cleanup projects
- Improving food access to reduce vehicle miles traveled
- Stormwater issues and green infrastructure
- Lead and asbestos contamination
- Pesticides and other toxic substances
  - + Other community-driven environmental justice priorities

- Healthy homes that are energy/water use efficient and not subject to indoor air pollution
- Illegal dumping activities, such as education, outreach, and small-scale clean-ups
- Emergency preparedness and disaster resiliency
- Environmental job training for occupations that reduce greenhouse gases and other air pollutants
- Environmental justice training for youth

## Projects you might not realize are EJ

- Workshops on safe and sustainable agricultural practices
- Solar microgrids
- Climate assessments
- Weather shelters at bus stations in rural areas
- Growing traditional foods
- Food source preservation for communities
- Permaculture
- Floodplain management
- Tree planting to address urban heat islands

- Green infrastructure improvement (e.g. rain barrels, rain gardens)
- EJ-themed mural project with youth
- Patient-centered climate resilience training and tools
- Plan for increasing community involvement in a county Climate Action Plan
- Citizen science: Collecting data from community members about the urban health environment
- Workforce capacity development for green jobs

# Case example: Tier 1

**Org type:** Tribal community-based non-profit organization

**Project description**: A non-profit organization is working with a local Tribe to better understand the need, desire, and potential barriers to supporting residential solar to increase energy independence of the Tribe. They propose a combination of Tribal community assessment through surveys, focus groups, and community meetings.

#### In their application,

- **Community of Focus**: Local Tribal community members, with a focus on underserved community members
- **Community Engagement**: Tribal community engagement through survey and focus group implementation, seeking to reach saturation. Public community meetings will be held, with specific accommodations to reach underserved populations, including ASL interpreters, childcare, and ensuring that the meetings are held in accessible locations.
- **Environmental Justice Issue**: Energy independence affected by high costs and fossil fuel dependence, reduction in greenhouse gas emissions.
- **Project Activities**: Survey, focus group, and community meeting implementation, with materials developed and sessions held in Tribal language for monolingual community members. The project aims to work with and continue the efforts of previous organizations to support the use and upkeep of residential solar panels.



# Case example: Tier 2

**Org type**: City Health Department

**Project description**: A City Health Department proposes a project to reduce high rates of lead exposure among disadvantaged community members in their City. The City aims to do this by improving testing rates through the development of Lead Remediation Action Plan. An Advisory Committee made up representative from the community develop and approve the Action Plan.

### In their application:

- **Community of Focus**: Includes Black community members, Indigenous populations, and low-income individuals within the City.
- Community Engagement: In addition to the Advisory Committee comprised of representatives from the impacted community, the City will hold a series of open meetings and workshops in-person and remote, prioritizing those communities with the highest rate of blood lead levels. Meetings will held at various times to accommodate different schedules and interpretation services will be provided.
- **Environmental Justice Issue:** High rates of lead exposure among the Communities of Focus, resulting from many of these community members living in houses built before 1978, in impoverished neighborhoods.
- **Project Activities**: Implementation of a representative Advisory Committee, community health assessment, action plan, collaboration meetings, and virtual and in-person listening sessions.



# Case example: Tier 3

Org type: Community-Based Organization (CBO)

**Project description**: An agriculture-focused CBO in a rural area is proposing a program that supports local farmers to transition towards sustainable farming practices.

### In their application,

- **Community of Focus:** Rural, low-income farmers
- **Community Engagement:** The non-profit organization will use their existing relationships with farmers in the area. The non-profit will hold informational sessions with the farmers to develop the design and delivery of the program.
- **Environmental Justice Issue:** Changes in farming practices affecting local farmers include rising input costs, climate variability, and the need to adapt to new technologies and market demands.
- Project Activities: The non-profit will conduct listening sessions with farmers, utilizing their input to develop a list of changing farming practices and ways to support them to address them. The program will prioritize the farmer's input to develop project activities and evaluation metrics.

# **Additional Considerations**

- Procurement
  - Must follow Federal requirements
- Land Acquisition and Purchase
  - Cannot exceed 50% of total budget
- Purchase of Equipment with a Unit Cost of More than \$10,000
  - o Is allowable, but must be approved by EPA
- Fiscal Sponsorship
  - Fiscal sponsor fees cannot be included as direct expenses in the project budget
- Human Subjects Research
  - o If selected, grantees are responsible for ensuring IRB approval
- Construction
  - Build America Buy America (BABA)
  - Subject to prevailing wage requirements relating to the Davis Bacon Act
- Quality Assurance Project Plans
  - Collecting, producing, evaluating environmental data, using environmental data in decisionmaking processes (e.g., regulatory compliance, risk assessment), Environmental technology projects
